RENEWAL INSTRUCTIONS:

- Your Pyrotechnic Operator License expires every even year, biennially on **August 31**, regardless of when it was issued.
- Proper fees and all other documentation must accompany each application. Any incomplete license package **WILL** be returned to the applicant. All questions on the application must be completed.
- Renewal application and fee **must be** postmarked by the Post Office on or before **August 31, 2018**.
- Attach a current copy of your ATF Letter of Clearance to this application.

- All paper renewal applications must be mailed to the above address, and must include check or money order. Credit cards are no longer accepted for paper renewal applications.
